## From Our Finance Council of St. Michael Church – Newark 2017-2018 Fiscal Year - Six Month Update Period ending December 31, 2017

Last August we provided you with an annual report of how we are doing as a parish. We ended the June 30, 2017 fiscal year with an operating deficit of \$26,706. We also stated that our deficit for the new fiscal year budget is \$48,489. We asked that everyone prayerfully review your own financial giving to the parish and for those who are able, to increase your contributions.

We are now half way through the 2017-2018 fiscal year, and we want to give you an update on how we are doing financially. You can see how we are doing in the report on the back of this page. Our operating deficit is just \$6,412 for the six months (YTD). This is far better than the \$24,000 deficit the budget shows for the six months. HOWEVER, our expenses are almost always higher during the second half of the fiscal year.

You likely face the same issues with your own personal finances. Within the "Building and Maintenance" category on the reverse side of this page would be snowplowing and our natural gas (heating) expenses. For the month of December, we paid \$2,125 for snowplowing, which is equal to our budget for the entire year. Likewise, for the first six months our natural gas bills totaled just \$3,881 while \$17,000 is budgeted for the whole year. There is more winter to come.

Under "Salary and Benefits," annually our medical insurance premiums go up on January 1<sup>st</sup> and we do our best to budget for it. Our *increase* over the six months will be \$1,200. In total, the amount for snowplowing, gas, and insurance could *increase* by \$15,000 in the coming six-month period compared to the July to December totals.

On the income side, we have positive news that memorials (donations in memory of someone) are up \$2,000 this year and bequests from wills/estates are up \$5,000. This is good news and helps us. However, it should be noted that it is possible that for the remaining six months of this fiscal year, we might receive no more memorials or bequests this year.

Turning to our regular collections, there is good news and bad news. If you look at the financial report on the back of this page, you will see collections are down \$9,000. This is because of the death of a major donor who gave a significant donation each year. On the good news side, except for that one contribution, our regular collections are up \$11,000 for the first six months compared to the same time last year.

This is your parish and we count on your support. We are very grateful for every contribution we receive and to everyone who has increased their contributions.

If you haven't increased your contributions, we invite you to prayerfully consider doing so now so that we may continue the ministries of our parish.
